NOTIFICATION FOR EXPRESSION OF INTEREST

EOI FOR "Cleaning and levelling of area at CFFP for further construction work."

Introduction:

Central Foundry Forge Plant (CFFP) a unit of BHEL was setup in 1976 at Haridwar to manufacture Steel Castings and Forgings. For its expansion activity, new shed/extended shed are to be made for which the identified area is to be cleaned & levelled for further construction at inside factory premise of CFFP.

CFFP invites expression of interest (EOI) from qualified and experienced service providers for the cleaning and preparation of the area. There is sand, slag, skull etc dumped at the identified area.

Scope of Work:

The scope of work includes, but is not limited to:

- Excavation / Disposal / relocation of sand / soil / building rubbish / malba / similar unserviceable / dismantled / waste furnace slag / skull and any other materials lying at proposed area by mechanical transport including loading, transporting, unloading to approved dumping ground for lead up to 2 km for all lifts, complete.
- Approx. size of proposed cleaning area is 20,000 Sqm (\pm Variation 15%).
- Assessment of the exact quantity of work required.
- Adherence to all safety regulations and guidelines to ensure a safe working environment for all personnel involved.
- It is mandatory for the bidder to provide all necessary tools, equipment, plants, and vehicles etc required to carry out the cleaning services.
- All required and valid documents/ permission for plants, machinery, Vehicle and manpower to be arranged by the bidder as per factory law.
- Dumping area preparation will be in vendor scope.

Site Visit:

All interested parties are required to visit the plant (CFFP, BHEL Haridwar) to assess the area/work in person before submitting their proposals. The site visit will enable potential bidders to understand & visualise the scope of work.

Submission Requirements:

Interested service providers are requested to submit the following documents:

- Company profile highlighting relevant experience and qualifications.
- Proposed methodology for carrying out the cleaning services & the estimated time required.
- Budgetary quote for carrying out the entire scope.

- d) Offer against this EOI must be submitted on or before 24th Apr 2024 via email/registered post/courier/in-person.

Prerequisite:

Tenderer should submit proof of having carried out successfully similar nature of work during last 10 years ending date of issue of EOI for this work (Similar nature work means work involving Excavation / Disposal / relocation of sand /soil / building rubbish / malba / similar unserviceable / dismantled / waste furnace slag / skull and any other materials).

In terms of value, the tenderer must meet either of the following conditions.

- a. Three similar completed works costing not less than the amount equal to 40% of the quoted /estimated cost, individually.
or
- b. Two similar completed works costing not less than the amount equal to 50% of the quoted /estimated cost, individually.
or
- c. One similar completed work costing not less than the amount equal to 80% of the quoted /estimated cost.

As a proof, work order and completion certificate(s) from the original client(s) must be submitted.

***Date of completion of work shall be the relevant date for calculating experience.**

Evaluation Criteria:

Proposals will be evaluated based on the following criteria:

- a) Experience and qualifications of the service provider.
- b) Proposed methodology for carrying out the cleaning services.
- c) Pricing proposal and cost-effectiveness.
- d) Time of completion.
