1.	<b>PQR point No. (i)</b> At page No. 4	“Bidder must have possessed at least 02 Nos. commercial vehicles such as Ambulances / Taxies / Cars / Buses / Jeeps and the same registered in the name of bidder since last three years from the date of publication of the tender” Should be read as <b>“Bidder must have at least 02 Nos. commercial vehicles such as Ambulances/Taxies/Cars/Buses/Jeeps or a combination of these, for the last three years from the date of publication of the tender. Vehicles should be registered in the name of bidder for above period”.</b>
2.	<b>Special terms &amp; conditions</b> <b>Annexure C point No. 6(i), page No. 7 &amp; 8</b>	“BHEL shall pay monthly hiring charges, including taxes as applicable. The payment will generally be made on monthly basis after receipt of the computerized bill in duplicate and verification with BHEL certification by Departmental representative (not below the rank of Sr. Manager) for satisfactory completion of the work. No advance money will be paid under any circumstances. Also no interest shall be paid due to delay in making the payment. The bills in duplicate along with log book duly signed by User/ Departmental Representative should be sent to BHEL within 15 days after the monthly use of vehicle. It should be ensured that there is no overwriting in the log book. Log book without signature of User/ Department’s representative at the specified places shall not be accepted for payment. Along with it, a monthly running summary shall also be submitted on prescribed format to Auto Pool by Department, for which vehicle has been allotted.” Should be read as <b>“BHEL shall pay monthly hiring charges, including taxes as applicable. The payment will generally be made on monthly basis after receipt of the bill in duplicate. No advance money will be paid under any circumstances. Also no interest shall be paid due to delay in making the payment. The bill in duplicate should be sent to BHEL within 15 days after the monthly use of vehicle”.</b>

3.	<b>Special terms &amp; conditions</b> <b>Annexure C point No. PAYMENT 6(iii), page No. 8</b>	<p>“However, payment shall be made by BHEL for extra kms run @ Rs. 2.00/km beyond 2400 Kms monthly running and discount shall be provided by the Contractor/service provider for less kms run @ Rs. 2.00/km below 1600 kms. monthly running”.</p> <p>The above clause is amended as below:  <b>Settlement of extra /less Kms:</b>  <i>If a car runs for more than 2400Kms per month or less than 1600 kms per month, such extra /less km log shall be maintained in records for all the 48 months of contract and at the end of which i.e. at the time of payment of 48<sup>th</sup> month’s bill, net extra/ less kms logged during the previous 48 months shall be aggregated and payment/ recovery shall be done accordingly at the rate of Rs. 2.00/km for each car. However, payment shall be made by BHEL for extra kms run @ Rs. 2.00/km beyond 2,400 Kms monthly running and discount shall be provided by the Contractor/service provider for less kms run @ Rs. 2.00/km below 1,600 kms. monthly running”.
