CORRIGENDUM- I for Revised PRE QUALIFICATION REQUIREMENTS.

Please refer above Tender Notice uploaded in BHEL website on 27.07.2021. The PRE QUALIFICATION REQUIREMENTS of the Tender Notice mentioned above are revised (**Additional Point “Bidder should furnish the details of minimum of 3 qualified welders”**). Following are the revised PRE QUALIFICATION REQUIREMENTS.

There is **NO CHANGE** in the last date of submission of tender documents. The Tenders (Technical Bid) will be opened on **03.08.2021 at 13:30 Hrs** at vendor complex, beside Administrative Building, BHEL Ramachandrapuram, Hyderabad. The agencies can download the Tender documents from BHEL website.

PREQUALIFICATION REQUIREMENTS:

- a. The following conditions have to be satisfied by the tenderer, with documentary proof to be enclosed with tender bid (Technical).
 - b. The contractor/bidder shall have an experience of minimum of two years in:
 - The contractor shall have minimum of two years' experience of working in high pressure welding works for similar components i.e. SS & CS Overlaying and high pressure joint welding in any ISO standard firms or in Power plants or in Pumps/Turbines/compressor welding works of manufacturing industries.
 - **Bidder should furnish the details of minimum of 3 qualified welders.**
- (OR)
- The contractors who have already executed the same/similar work in 70 bldg. Pumps of BHEL Hyderabad are eligible.
- c. Average annual financial turnover during the last 3 years, ending 31st March of the previous Financial Year (should submit balance sheet & P&L account for last 3 Years- certified by

Charted Accountant), should be at least **30% (Rs.4.54 Lakhs)** of the estimated cost. Further, if the tenderer fails to submit the figure(s) for 3-years, non-submitted year will be considered as “0” (Zero) for averaging the turnover.

d. Particulars of experience / credentials for the works executed of similar nature as said in 2.0(i) during not older than 7 years (Completion and experience certificate of the works to be enclosed) ending last day of month previous to the one in which applications are invited should be either of the following:

- Three similar works completed/executed costing not less than the amount equal to **40%** (each work **Rs.6.05 lakhs**) of the estimated cost of work. **Or**
- Two similar works completed/executed costing not less than the amount equal to **50%** (each work **Rs.7.56 lakhs**) of the estimated cost of work. **Or**
- One similar work completed/executed costing not less than the amount equal to **80%** (each work **Rs.12.10 lakhs**) of the estimated cost.

e. Experience certificate issued by BHEL, RC Puram in case any work executed in BHEL, RC Puram for past three years. Any adverse remarks in the experience certificate will be a disqualification factor.

f. The offers of the bidders who are on the banned list as also the offer of the bidders, who engage the services of the banned firm shall be rejected. The list of banned firms is available on BHEL website www.bhel.com

g. Contractor shall furnish valid ESI Code Number and PF Code Number (proof of having code No. to be enclosed).

h. **GST Registration No:** (Proof of having Code No. to be enclosed): If not available proof of application submitted for obtaining GST with concerned department shall be enclosed. (Bills will not be processed until proof of having GST Code No. submitted) and the contractor has to conform to the GST law as applicable.

i. Contractor shall furnish PAN No. (In case not available, proof of having applied with acknowledgement from concerned authority) & Income Tax Assessment/declaration copy for the last three (3) year shall be enclosed with the bid (self-attested copies).
