No. 12(11)/2017-SI dated 22.06.2017.

3. Further, Annexure “G” & Annexure “H” to be read as following.

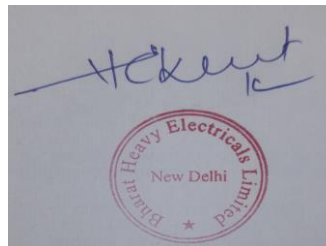
