The tenderer must submit this corrigendum slip (duly signed and stamped) along with tender documents.

### **Benefits Guidelines for Micro, Small Enterprises ( MSE) .**

1. Tenders to MSE suppliers shall be issued free of cost & no EMO wherever called for will be insisted upon. Such MSE bidders shall submit along with bid, relevant documents including valid certificate. Date to be reckoned for determining the deemed validity will be the date of bid opening ( Part I in case of two part bid ). Non-submission of such document will lead to consideration of their bid, at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are, not submitted before price bid opening. If the tender is to be submitted through e-procurement portal, then the above required documents are to be uploaded on the portal. Documents should be notarized or attested by a Gazetted Officer.
2. MSE Suppliers can avail the intended benefits only if they submit attested copies of any of the following :
  - (a) Entrepreneurs Memorandum ( EM ) II certificate having deemed validity five years from the date of issue of acknowledgement in EM II ), **or**
  - (b) CA Certificate ( as per proforma enclosed where deemed validity of EM II certificate of five years has expired ) applicable for the relevant financial year ( latest audited ), **or**
  - (c) Valid NSIC I MSMED I DIC Certificate, **or**
  - (d) Any other source notified by MoMSMED

It shall also be obligatory on part of the bidders to inform BHEL of their upgraded status by providing the date of upgradation
