**Queries-01**

**Boom & Jib Lengths:**

The Boom length is mentioned as "To suit aforesaid lift requirements" & the jib length is mentioned as "At least 18m".

We request that the maximum height be specified in tender and is to be met with a combination of Main Boom + Jib (instead of specifying the Jib length). This will allow more cranes / vendors to participate. In this instance suggest the maximum height be specified as 100 metres to be met with a suitable combination of Boom + jib.

**REPLY:** As per clause no 1.1.1 Technical Requirements & Duration of Deployment & SI No 5, Details & requirements should be read as under:

**The structure/components to be lifted above ceiling Girder are roof structures, silencers etc. The maximum weight of these would Up to around 10 MT at elevations of up to around 75 m. Majority of these would require 'Boom + Jib' combination to obtain required Elevation and horizontal reach at those elevations**

**3.0 COMMENCEMENT OF CONTRACT, REGULAR CONTRACT PERIOD, TERMINATION & FORECLOSING**

The contract period shall commence from the successful load testing of Crane with mutually agreed boom length at project site location and its written acceptance by BHEL. The Contract Period (duration of hiring) will generally be as indicated under 'Regular Duration' in tabular form earlier here. Contract Period may be extended depending upon the requirement of BHEL as specified therein.

**Our Suggestion for Clauses 3.0**

Based on deployment letter Crane reaches the site as per scheduled time, than there should not be any delay in Load testing. If any delay is happening in the Load testing from your side due to any reasons, than we should be compensated for the same or we should get the rental from the day the crane reaches the site.

**REPLY:** The clause mentioned in the Tender Specification holds good in this regard.

**12 SCOPE FOR MOBILISATION & DEMOBILISATION**

Contractor shall arrange suitable capacity assist cranes and Tools & Tackles at the respective project site for unloading of crane sub-assemblies, components, assembly, dismantling/loading of the crane during mobilization & de-mobilization of crane. Contractor shall also arrange to and fro transportation, skilled manpower and consumables at his own cost.
