Following clarifications are issued against the subject tender.

1) Que by Bidder : Refer item No. 2300 of Rate Schedule, Page 1 of 8. Please delete the word "Supply" in 2nd line.

**Clarification by BHEL** : - Item 2300 is only summary & No rate is asked against this item. Rates to be quoted by bidders in subsequent items only. Further break up of St no-2300 is clearly mentioned in scope. Hence no deletion is required.

2) Que by Bidder Refer item No. 2301 of Rate Schedule, Page 1 of 8. Please delete the word "Grating" in 7th line.

**Clarification by BHEL** -It is correct and same is in scope of vendor.

3). Que by Bidder : In rate Schedule , we feel that St. No. 2302, 2303, 2304 & 2305 is missing in Rate Schedule. Please clarify this.

**Clarification by BHEL** -It is not applicable for this package and hence not appearing.

4) Que by Bidder : Distance of fabrication yard to erection site. Please inform the approx distance from fabrication yard to erection site.

**Clarification by BHEL** -Please refer clause no-4.0.4 & 4.6.4 .However distance of fabrication yard is within 2 kilometer (km) radius from Erection site.

5. ) Que by Bidder : Construction Power- We shall be provided two locations for provision of Construction Power.

**Clarification by BHEL** -As per contract with customer only at one location (single point) Construction power shall be provided and further distribution is to be done by BHEL Contractor.

6. Que by Bidder Also please confirm the quantity mentioned in Rate Schedule is for 1 (One) Block. The other block is of same quantity.

**Clarification by BHEL** - Price bid in the contract is for only 1 Block and other block is of same quantity.

7. Que by Bidder : Please also confirm 250 MT Crane (2 Nos.) which are to be provided from your end shall be for 1 (One) Block only.

**Clarification by BHEL** -Please refer Appendix-I in which supply of cranes by BHEL is clearly mentioned. 250 MT BHEL Cranes (2 Nos.) is basically for Boiler erection and shall be made available for Bunker work as per requirement at site and on sharing basis only.

**Vendors to note Further:** 180 MT crane by vendor shall be made available at site as per load chart only and in good working condition only. 250 MT crane if needed further then only it will be made available that too as per site priority.

**Above clarification shall be be part of tender specification. Bidders may please download this document from web and enclose print out of same with technical bid** duly counter signed by your authorized signatory and stamped with official seal as a token of your unqualified acceptance of this amendment.
