Providing Consultancy services for proposed projects as per Annexure-I for Civil / Electrical /Air conditioning works at BHEL- EDN Premises. The scope of work involves rendering service for Civil, Electrical and Air conditioning services such as:	
a) Preparation of preliminary drawing with Contour Map in respect of the existing ground levels & furnishing detailed layout / structural / Architectural design drawing after ascertaining the stability of the existing building on which vertical expansion is expected and allied services as desired by BHEL time to time. Including visits by the Architect / consultant/ their representatives to the proposed site of constructions & discussion with concern authorities periodically for the total span of the contract.	%
b) i. Design of power supply and lighting system, layout drawings for Lighting, power supply system, Telephone wiring, LAN Networking, Fire Alarm system, integrating with other services, Single line diagrams, Bill of Quantity with Detailed specifications, Price estimate, Rate Analysis supported with Price lists / Quotations, Product Catalogues wherever necessary.	
ii. Interact and coordinate with Employer representatives and submit stage-wise draft schemes for their approval.	
iii. Prepare separate Tender Documents for Electrical and Air conditioning work and also incorporation BHEL terms and conditions, BOQ and Drawings.	
iv. Periodic inspection of site and coordinate with Electrical & other relevant contractor to resolve any clarifications arising during the course of execution of work, in consultation with the Employer representatives.	

- v. Witness commissioning testes and certify conformance to standards and Tender requirement, provide as built drawings both (Hard copy and Soft copy)
- c) Site study, discussions with User & Executing Departments and making necessary Heat Load calculations to design the plant capacity including all accessories. Preparation of Estimate with necessary backups, specifications and Drawings including BOQ.

Preparation of final Revised documents, if required, like specifications, bill of Quantities, Estimates with necessary backups, Drawings and documents for tendering purposes as per the requirement of BHEL (3 sets)

Assisting the Tender Committee in evaluation of tenderers and interacting with the tenderers, if and when required by BHEL, till the placement of order on the successful tenderer.

Liaison with the successful contractor in executing the work, Visit site periodically, verify test results obtained during the commissioning of the system and assist in taking over the system from the contractor.

Liaison with the successful contractor in sorting out the problem, if any, during the guarantee period visit site if required, verify test results obtained during the guarantee period and assist in taking over the system from the contractor after the guarantee period.

The scope of consultancy services, scale of fees and mode of payment shall be as detailed in Annexure II & III enclosed. The competitive offer should be inclusive of all taxes and levies as applicable from time to time.

### SCOPE OF CONSULTANCY SERVICES

The architects / consultancy services shall include the following:

- 1. To interact and take the instructions from the representatives of the employer.
- 2. To prepare site plans and landscape design.
- 3. To prepare preliminary drawings and design, outline specifications and preliminary estimates of costs.
- 4. To prepare final plans, drawings and design, specifications, and also final estimates of cost by cubic measurement or otherwise (including carrying out necessary revisions, till receipt of approval by the employer) & submit reports to enable the employer to take necessary decisions.
- 5. To assist the employer to submit required applications, drawings etc., to the corporation and / or any other local authority to obtain approvals, licenses and /or sanctions.
- 6. To prepare and submit detailed working drawings and estimate for all works for which the services are rendered by the architects. The architect shall furnish the calculations of the above designs when called for in specific cases.
- 7. To prepare detailed specifications for various items of work mentioned above.
- 8. To prepare tender documents / tender specifications with bill of quantities for floating tender.
- 9. Periodical supervision of the work to ensure that the work is being carried out as per the design and specifications till the completion of project in all respects, Coordinate with the contractor and resolve any clarifications arising during the course of execution of work and with the approval of the employer's representative.

- 10. To prepare and submit five complete sets of working drawings "as built and Instruction for the employer along with reproducible of all the drawings.
- 11. All the above scope of services mentioned for Civil and structural works shall also apply for the following services.
- (a) Water supply, Sanitary, Drainage, Fire Fighting Services, Interior decoration and furnitures, roads and drainages, compound wall, lift facilities.
- (b) Electrical works including Telephone wiring, LAN Networking, Fire Alarm system and Air conditioning works.
- 12. The architects shall give their design for the work and calculations for the designs and shall be fully responsible for both the design and calculations. The architects have to examine at their own cost he stability of the existing building on which vertical expansion is proposed.
- 13. The architects shall provide bar bending schedules for all the RCC works.
- 14. The architects shall furnish the design calculations for all the structures. These designs shall be vetted by reputed institutions like Indian Institute of Science / Bangalore etc, to be nominated by BHEL for proof checking.
- 15. The architect/ consultant shall help BHEL in the concrete mix design and give necessary know how in the use of concrete admixtures if require.
- 16. The architects shall furnish a certificate about the satisfactory completion of the work.
- 17. Schedule for the issue of drawings should be mutually agreed to and a proper time table to be set. It is expected that the RCC framed structural drawings including foundations should be fully available at the time of start of work.

### **ANNEXURE-III**

### **TERMS AND CONDITIONS**

### SCALE OF FEES

The employer will pay the remuneration for the services to be rendered by the architects for the above said work at the rates quoted by them on the "actual cost of the work" and finally accepted by the BHEL. The actual cost of the work" for this purpose shall exclude the cost of land and cost of such equipments and plants which the buildings is designed to house as well as all types of work with which the architects are not directly concerned or involved. The cost shall include the cost of all the material supplied by the employer for the construction but exclude the statutory increase of prices of material within the specified project period. The total remuneration payable for the services to be rendered by the architect under this contract however shall not exceed 1.3 times of the remuneration arrived at on multiplying the accepted rate by the bare estimated cost of the work as finally vetted and accepted by BHEL based on CPWD – DSR up dated rates.

**CONSULTANT** 

1. If the project is abandoned or suspended or terminated under Para (Termination of Agreement) 2 the architects shall be paid their fees for the services already rendered by them. The provisions of Sl No.12 of Page (4) (Scope of consultancy Services) and Sl No (2) of Page (10) (Termination of Agreement), as regards the architects responsibility shall continue to apply in respect of the work for which they received remuneration, inspite of the abandonment, suspension or termination as aforesaid.

#### 2. SECRECY

The architects shall not disclose any information furnished to them by the Employer nor any drawings, reports and any other information prepared by them, without the prior written approval of the employer, except in so far as disclosure is necessary for the performance of the architects work and services there under. The architects shall however be subject to the provision of the official secret act 1923, pertaining to such information at all times.

### 3. THE COPY RIGHT

The design prepared by the architects shall be the copy right of the architects but the architects shall not disclose the contents of drawings and design prepared by them in respect of the said works to any person or authority without the prior written permission of the employer.

4. The architects hereby agree that the fees to be paid to them as provided herein will be for the full discharge of functions to be performed by them in accordance with a time schedule to be mutually agreed upon and no claim whatsoever, shall lie against the employer in respect of any proprietary or patent rights on the part of any other relating to formulae, plans, models, drawings or designs. The architects shall indemnify and keep indemnified the employer against any such claims and against all cost and expenses paid by the employer in defending himself against such claims. The architect shall always hold the employer indemnified against any claims arising out of this agreement. Or any claims arising from third parties in respect of formulae, design or drawings employed by the architects in their agreement / contract.

### TERMINATION OF AGREEMENT

- 1. Either party may terminate this agreement at any time by giving to either of them sixty days previous notice in writing.
- 2. The financial and legal responsibility for the adequacy, correctness and justification of the quantities, design, drawings and specifications furnished by the architects shall be with the architects. All errors and omission in the design, drawings and quantities or specifications furnished by the architects/consultant shall be rectified by them at their own cost. The architect / consultant further indemnify the employer fully against any and all losses arising out of bad or defective drawings, designs and specifications.
- 3. After the completion of the project, the consultant has to submit BHEL all the reproducible of the drawings furnished in connection with this projects.
