QUERY 01: As per scope of work the transportation of material is in contractor's scope. We wish BHEL can provide the material delivery at site/stores, as the cost of equipment is not know to us to cover the transit insurance cost etc. secondly the cross country transportation is for a distance of approximately 1350 kms and it is mentioned that, the container security amount will not reimbursed (under detailed scope of work 4.00.1 point No 11) Therefore we request for consider the material delivery to site.

CLARIFICATION TO QUERY 01: BHEL wishes to clarify that scope of work shall be as per tender conditions.

QUERY 02: Whether the Turbine units shipped to Finchaa sugar factory can be unloaded and kept inside the TG house.
