Following addition/ amendment in Clause No.5 (PROCEDURE FOR SUBMISSION OF TENDERS) in NIT is as under: -

1. In addition to submission of paper bid as per clause no. 5 of NIT, bidder may submit offers by E-mail also.
2. The tender should reach via E-Mail at BHEL HERP Varanasi email ID: - tenderherp@bhel.in by 02:00PM on or before the due date i.e 11.05.2020. You are requested to submit your most competitive rates along with all tender documents duly signed and stamped on each page. BHEL will not be responsible for delay in receipt of tender(s) sent by E-Mail.
3. The tender is to be submitted by **E-mail in PDF format indicating subject description as Part-1 "Techno-commercial Bid" OR Part-2 "Price Bid"** with tender number & due date of submission.
4. E-mail of Part-1 "Techno-commercial Bid" shall contain documents required as per Para 3.0 & 4.0, all annexures and scan copy of documentary proof for submission of EMD & tender cost as mentioned in NIT. E-mail attachment of Part-1 "Techno-commercial Bid" will not be password protected PDF format.
5. E-mail of Part-2 "Price Bid" shall contain percentage of service charges as per the Price-Bid format (**Annexure-J**). E-mail attachment of Part-2 "Price Bid" **must be password protected PDF format** and same shall be provided at the time of opening of **Part-2 "Price Bid"**
