- 1. Ref. S.No. 2 of Enquiry letter:-** As per GCC, Rev.04, Part-I (Techno-Commercial Bid) & Part-II (Price Bid) were covered under S.No. 3.0 & 4.0 respectively of Instruction to Bidders (Vol.IA) but as per GCC, Rev. 05, these are covered under Instruction to Bidders under Vol. I.
- 2. Ref. S.No. 4 of Enquiry letter:-** As per GCC, Rev.04, "Instruction to Bidders" & "General Commercial Terms & Conditions" were covered under Part-A & Part-B respectively of Vol. I, but as per GCC, Rev. 05, these are covered under Vol. I.
- 3. Ref. S.No. 12 of Enquiry letter:-** Clause 15 of Vol. I, Part-A of Instruction to Bidders in GCC, Rev. 04 has been replaced by Clause 15 of Instruction to Bidders in GCC, Rev.05. This clause pertains to the process of Reverse Auction.

However, Bidders must refer to GCC, Rev.05 for other terms & conditions which supersedes the many requirements of GCC, Rev.04.
