

## CORRIGENDUM

**A corrigendum is issued for “Supply, Installation, Commissioning and Maintenance of 17 numbers Digital Photocopier machines on rental basis for 3 years period” tender (NIT\_25245) with the following clauses.**

### **1. Multiple Bids:**

The bidder in his own interest shall submit only one bid. If a bidder submits Multiple bids, all the bids are liable for rejection. Bids shall be considered “Multiple” in the following circumstances:

- a) Two bids by the same party.
- b) If one bidder is the Affiliate of another bidder.

For the purpose of this clause “Affiliate” shall mean with respect to any Person, any other Person that, directly or indirectly, controls, is controlled by, or is under direct or indirect common control with, such Person, or is a director/ member / officer/ employee of such Person or of any Person who would otherwise qualify as an Affiliate of such Person pursuant to this definition;

“Person” for the purposes of this definition shall mean any natural person, individual, corporation, limited partnership, co-operative, general partnership, joint stock company, joint venture, association, company, trust, bank, trust company, land trust, business trust, corporate body or other organization, whether or not a legal entity.”

### **2. Fraud Prevention Policy:**

The bidder along with its associate / collaborators / sub-vendors / consultants / service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about fraud or suspected fraud as soon as it comes to their notice.

### **3. Affidavit:**

Applicant shall ensure furnishing an undertaking in the form of an affidavit(As per Annexure-I) on non-judicial stamp paper valued `100/- and duly self-attested by the Bidder.

### **4. The loading pattern shall be decided on the following basis:**

If there is a tie between Two or more vendors and resulting in same L1 ranking among the equal ranked vendors, the sub-ranking will be done as detailed below, to differentiate :

- i) Vendor having MSME certificate will be ranked first. If there is tie for two or more vendors having MSME certificate, then vendor having earliest date of commencement will be ranked first.
- ii) “Overall (total) lowest quoted rate” will be considered for ranking of respective schedule.

### **5. Extension of due date :** Tender submission due date is extended up to 17.12.2015, 14:00 hrs and tender opening by 17.12.2015, 14:30hrs.
