SUBJECT: Corrigendum to Enquiry (E-4686 Dtd.18.12.2014).

A. Delivery Schedule as per SI No.12 of NIT stands amended as follows:

02 nos: 18 months from the date of LOI & 02 nos: 20 months from the date of LOI.

- B. Price Schedule as per point no 06 of enclosures to NIT stands revised.
 Bidder to submit Price Bid strictly as per this revised price schedule only (Uploaded over BHEL website).
- C. The excess material (i.e. Cement & Steel) required over & above the quantity quoted by vendor during tendering stage will be arranged by vendor themselves. However, if vendor desires to take the excess material (i.e. Cement & Steel) from BHEL, BHEL will issue the same at the rate mentioned in Clause no. 22 of NIT against secured Bank Guarantee (BG) (this will be a separate BG over & above the contract BG). Value of this separate BG will be equivalent to the cost of excess material desired by vendor at the rate mentioned in Clause no. 22 of NIT. The cost of excess material (i.e. Cement & Steel) at the rate mentioned in Clause no. 22 of NIT shall be recovered from the Running Bill of vendor.
- D. BHEL intends to split the order on the basis of following criteria.
 - A. Unit- 1&2 will be referred as Block-A & Unit-3&4 will be referred as Block-B in the Tender.
 - B. Unit-1&2 (Block-A) & Unit-3&4 (Block-B) is proposed to be awarded to separate bidder on compliance of following:
 - Ranking of bidders as L1, L2, L3 and so on shall be established based on 'total cost to BHEL' which shall contain two components namely bidders quoted price (excluding service tax on E & C, civil works and PG test) as first component (sl. No.1.0 of Price Schedule) & cost on account of cement & steel (Sl. No.2.0 of Price Schedule) as second component.
 - 2. L-1 Bidder shall be considered for award of Unit-1&2 (Block-A).'Total cost to BHEL' for Block-A will be the half of the L1 'total cost to BHEL' for 4 numbers of cooling towers (The quantity for free issue of steel & cement at Sr. No 2 of price schedule will be reduced to half).
 - 3. For award of Unit-3&4 (Block-B), L2 bidder shall be given an option to match their 'total cost to BHEL' for two number cooling towers with the finalized 'total cost to BHEL' of L1 bidder for Block-A. To arrive at order price for Block-B, the quantity & cost of free supply of cement & steel of L2 bidder (Sl. No.2.0 of Price Schedule) for the O2 nos of cooling towers i.e. half of quoted will remain fixed & the bidder quoted price at Sl No. 1.0 of Price Schedule (excluding service tax on E&C, Civil Works & PG test) for O2 nos of cooling tower will be adjusted proportionately to match with the total cost of L1 Bidder. Service tax shall be calculated on the revised value of E&C, Civil works, PG Test and will be added to arrive at total ordering value of L2 bidder. In case of refusal of L2 bidder to match their 'total cost to BHEL' with that of L1 bidder, option will be given to L3, L4 & so on in the similar manner.
 - 4. In case none of the bidders (other than L1) agree to match their 'total cost to BHEL' with that of L1's 'total cost to BHEL', L-1 bidder will be awarded all 04 nos of cooling towers.
 - 5. In case order is split amongst two bidders, each bidder will be required to submit the drgs / documents as per their design for BHEL/customer approval.
 - 6. In the event the order is split the delivery for each finalized bidder shall be
 - i) 1 no: 18 months from the date of LOI.
 - ii) 1 no: 20 months from the date of LOI.
- E. Due date of tender submission is now extended up to 04.06.2015 (02:00 PM).
