The following additions/ amendments are made in tender document as mentioned below:

- 1) Due to introduction of Goods and Service Tax (GST) in place of existing taxes, the Un-price bid and Price Bid is being modified suitably and will be valid for quoting rates instead of old Un-Price Bid and Price Bid. The new/ modified Un-Price Bid and Price Bid is as enclosed.
- 2) The GST will be applicable in place of existing taxes and in tender document all taxes may be read as GST.
- 3) At clause no. 14 of General Terms and conditions the clause (g) and (h) are cancelled and may be read as per following clauses:-
  - g) As GST is to be introduced by Govt. of India in place of existing taxes, the same shall be payable after submission of GST compliance tax invoices on which BHEL may claim GST credit as per GST law/ rules.
  - h) The bidder must quote his rates considering benefits of GST including Input Tax credit in the quoted price.
