  - g) As GST is to be introduced by Govt. of India in place of existing taxes, the same shall be payable after submission of GST compliance tax invoices on which BHEL may claim GST credit as per GST law/ rules.
  - h) The bidder must quote his rates considering benefits of GST including Input Tax credit in the quoted price.
