A) Explanatory Notes for PQR 'C'- 'Technical'

1. 'Executed' means the vendor should have achieved the criteria specified in the Common QRs even if the Contract has not been completed or closed.
2. For the purpose of PQR, 3.5 TPH shall be considered equivalent to one MW where ever rating of BOILER is mentioned in TPH. Similarly where ever rating of Gas Turbine is mentioned in terms of frame Size, ISO rating of the same in terms of MW shall be considered for evaluation.

B) Explanatory Notes for PQR 'D'- 'Financial'

1. Net Worth = Paid up share capital* + Reserves (* : Share Capital OR Partnership Capital OR Proprietor Capital as the case may be)
2. Profit shall be NET Profit (PAT + Non Cash Expenditure viz depreciation)
