1. CLARIFICATION

Please refer page 75 to 94 of Tender specifications. The weights given in table are for some individual components and are approximate. The total weight will be about 2000MT after release of all shipping lists. Presently the weight given is indicative only and not the total weight of components.

However for E&C purpose, the total weight including piping and pressure parts is to be considered as 2400 MT. The table from BHEL/Trichy enclosed below also shows indicative weight as many shipping lists are not yet released. However for assessment the weight shall be as follows
