With reference to Pre-bid meeting held on 19-04-2024, please refer following changes in NIT terms -

14 of STC	MOU & Its Validity: Validity: 1 year from the date of signing of MOU.	9 months from the date of signing of MOU.
24 of STC	Mode of Payment for Payment terms mentioned at clause no.23 of STC- Payment shall be made directly to the supplier/ vendor by BHEL through NEFT/RTGS.	Mode of Payment for Payment terms mentioned at clause no. 23 (3.2 A) of STC- Payment shall be made through Irrevocable Letter of Credit (ILC). All charges related to ILC shall be in vendor's account. ILC shall be opened at the time of FAT with 3months validity. Amount of ILC shall be equal to the value of materials offered for inspection. Usance period of ILC will be 60days starting from the date of receipt of complete GST invoice along with documents as mentioned under clause 23.A of STC in BHEL's bank. Mode of payment for all other payments, ie. for clause no. 23 (3.2 B), 23 (3.2 C) & 23 (3.5) shall remain same as per NIT.
