AA) CLARIFICATIONS TO THE QUERIES

QUERY 1: Refer Page 106 of 126 SI No. DD of Part I Technical specification: Welding involved in "Process impulse tubing and Pneumatic tubing fittings"

CLARIFICATION 1: SI No 1 indicating CS pipe, SI No 2 indicating Cr-Mo pipe & SI No 4 indicating SS tubes needs welding. But SI No 3, 5 & 6 indicating SS tubes normally have ferrules for fixing, so no welding is involved in it.

QUERY 2: Refer Page 106 of 126 of Part I Technical specification:"Fabrication, erection of structural steel" SI No. C & D: Since the sizes of plates are given, whether the dimension column to be referred for numbers?

CLARIFICATION 2: Quantities mentioned in dimension column for SI No C & D shall be considered as 'No of Plates required'.

QUERY 3: Refer Page 108 of 126 Part I Technical specification: "Pipe Quantities". Quantities are given in 'meters'. Size details reg:

CLARIFICATION 3: Refer page no 117, 118 & 119 of 126 wherein size wise pipe quantities are mentioned. Depending on temperature and pressure the size shall vary. For eg live steam pipe size shall be having thickness of 6" inch size & so on.

QUERY 4: Welding specification of tubing as well as piping reg:

CLARIFICATION 4: As per clause No 4.16.3 point (A) Part I Technical specification, Piping works shall involve either Tig or Arc Welding. However the welding rods specifications and make shall be informed at the time of execution.

QUERY 5: Piping specifications: Various class of pipes, i.e for water line/steam line/oil line etc reg:

CLARIFICATION 5: Pipe schedules and sizes are mentioned in page no 117,118 & 119 of 126 Part I Technical specification for steam and drain lines.

QUERY 6: IBR Welder reg: Whether IBR certified welder is to be deployed or alternatively welder certified by BHEL site engineer is acceptable?

CLARIFICATION 6: Refer page no 39 of 126 Part I Technical specification, clause no 4.19 (C) (2)

CLARIFICATION 7: Refer page no 40 of 126 Part I Technical specification, Clause no 4.19 (N)

QUERY 8: Refer Page 45 of 126 Part I Technical specification, 'Terminal points', Size wise quantities reg:

CLARIFICATION 8: Refer page no 108 of 126 Part I Technical specification, Clause (K) for pipe quantities. Refer page 117,118 & 119 of 126 Part I Technical specifications for sizes of pipes

QUERY 9: Port of Entry reg:

CLARIFICATION 9: For Finchaa Site at Ethiopia, the port of entry is Djiboti as per contract agreement with customer and as detailed in Part I Technical specification. Hence no other port shall be used for supply of materials from India to Finchaa site by BHEL.

QUERY 10: Import duty at Ethiopia for tools/tackles/consumables of contractor reg:

CLARIFICATION 10: The T&P which are to be taken by contractor to Finchaa site shall be declared before taking from India .Otherwise it will attract customs duty. The list of T&P, Consumables declared by the tenderer will be submitted to customer and approval shall be taken by them from customs authority, so that custom duty shall not be charged on T&P.
