**AA] Qualification Requirement specified in page 2 of "NIT + GCC" of the subject tender has been revised as given below:**

**Qualifying Requirements (QR)**

Bidder must fulfill the Qualifying Requirements as under in order to be considered as technically qualified for this Tendering process

- a.1) Bidder must have in last 7 years as on 31.08.08, executed the work of Erection, Testing and Assistance for Commissioning of **Electrical and Control & Instrumentation work** in any Power Plant or any Industry, in any one of the jobs listed hereunder:
- a.1.1) One similar job of at least Rs 184 lakhs value in a single Work Order in any Industry, **OR**
  - a.1.2) One Job of Electrical Works AND one job of Control & Instrumentation works, each of at least Rs 92 lakhs value, in any Industry, **OR**
  - a.1.3) Two similar jobs of at least Rs. 115.00 lakh value per job, **OR**
  - a.1.4) Two jobs of Electrical Works AND two jobs of Control & Instrumentation works, each of at least Rs 68 lakhs value, in any Industry, **OR**
  - a.1.5) Three similar jobs of at least Rs. 92.00 lakh value per job, **OR**
  - a.1.6) Three Jobs of Electrical Works AND three jobs of Control & Instrumentation works, each of at least Rs 46 lakhs value, in any Industry, **OR**
  - a.1.7) Electrical and Controls & Instrumentation System work in a Thermal or Gas Based Power Plant of at least one unit of **100 TPH** or equivalent or higher rating, in a maximum of two work orders, **OR**
- a.2) Bidder must have been Techno Commercially Qualified by any Power Sector regions of BHEL, for any of the options under a.1, in the last three years as on 31/08/2008

**AND**

- b) Bidders must have achieved an average annual financial turnover (Audited) of Rs 69 Lakhs or more over last three Financial Years (FY) ending 31/03/2008 or 31/03/2007 if Accounts for FY 07-08 has not been audited.

**AND**

- c) Net worth of the Bidder based on the latest Audited Accounts as furnished for 'b' above should be higher than 50% of the Paid-up Capital in case of companies

**AND**

- d) Bidder must have earned cash profit in any one of the three Financial Years as applicable in case of 'b' above based on latest Audited Accounts.

**Explanatory Notes for QR 'a'**

1. The word 'executed' means the bidder should have achieved the criteria specified in the QR even if the total contract has not been completed or closed
  2. For the purpose of evaluation of QR, one MW shall be considered equivalent to 3.5 TPH wherever rating of HRSG/Boiler is referred/mentioned in MW
  3. The word 'similar job' means the work of Erection, Testing and Assistance for Commissioning of **Electrical and Control & Instrumentation work** in any Power Plant or in any Industry.
