CORRIGENDUM

Subject: BHEL participation in ELECRAMA exhibition- Corrigendum with regard to PQR of the Tender and extension of due date of submission

This is with reference to BHEL's notification no. **CC/EXDE/01/2017-18** dated **01.02.2018** seeking fabrication of BHEL's custom built stall in ELECRAMA 2018 exhibition to be held at Greater Noida from 10th to 14th March, 2018.

The modifications in the NIT terms are as under:

- 1. Under Annexure-III A, Section 'E' of BOQ of design and Scope of Work, Sl. No. 10' i.e. "LED lit 12 mm hardened glass flooring on the existing wooden platform, in place of carpet flooring (sl. No. a.1 & a.2), for display of Solar PV cells" stands deleted from BOQ of design and Scope of Work. Accordingly, the bidder need not quote the price for the said item under Annexure-VI of the Price Performa of the Tender. The Total Price at 'G' shall be without the same.
- 2. The NIT terms relating to PQR, taxes & duties, payment terms, LD/Penalty stands revised and may now be read as attached in **Annexure II.**
- 3. The rest of the requirements/ clauses of the tender remain the same as per earlier NIT no. CC/EXDE/01/2017-18 dated 01.02.2018.

The last date for receiving the response was 09.02.2018. In view of above modifications in the NIT terms and conditions relating to PQR, the due date for receiving the proposals has now been extended to **2 PM/12.02.2018**. Time and date for opening the bids shall now be 3PM/12.02.2018.

5.0 TAXES

- **5.1.** It is mandatory to comply with all taxes applicable for the required services. Your price should be all inclusive, **except GST**. The amount towards GST should be indicated separately in the specified place in Price Performa enclosed as **Annexure-VI**.
- 5.2. To enable BHEL to avail GST Input tax credit, contractor shall submit GST complaint Tax invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Such invoice shall be submitted within prescribed time limit in the name of Unit/Region/Division/Office as instructed by BHEL.
- 5.3. Payment shall be made to contractor only after submission of GST complaint tax invoice as mentioned above and other relevant documents. However, to protect BHEL's interest for GST input tax credit, GST portion amount along with notional interest on GST credit for 2 months' period (presently rate of interest is @ 24%) shall be withheld and the same shall be released only after confirmation from GST website/portal that such invoice has been declared in GSTR-1 return filed by contractor within the stipulated time for relevant period and tax amount thereon has been paid by contractor to Govt. within the stipulated time period as per GST Law.

- 5.4. In case GST credit is delayed/denied to BHEL or subsequently recovered form BHEL due to non/delay in filing of GSTR-1 Return or delay in/non-payment of tax to Govt. by contractor or for any other reasons not attributable to BHEL, in such case any financial implication on BHEL on account of delay/loss/recovery from BHEL of such GST Credit along with interest levied/leviable on BHEL till the time GST credit is available to BHEL, shall be recovered from the contractor's bill and/or adjusted against GST amount not paid as indicated above.
- 5.5. Irrespective of refund of GST Credit and interest thereon to BHEL by GST portal upon subsequent declaration of such invoice by contractor in his GSTR-1 for any period after due date of such return and/or payment of GST thereon by contractor on GST portal, the notional interest for delayed period of GST credit (i.e. delay for the period when GST credit is actually allowed and the period when GST credit should have been allowed had contractor declared such invoice in his GSTR-1 and paid tax thereon in the relevant month as per GST law) shall be recovered form contractor.
- **5.6.** GSTIN of BHEL will be provided to the contractor by BHEL within 30 days from the placement work order.
- 5.7. Payment to the Contractor will be subjected to the TDS as per rules in force from time to time. The Tax deduction at Source (TDS) shall be done as per the provisions of the Income Tax act and GST, as amended from time to time and a certificate to this effect shall be provided to the contractor by BHEL.
- 5.8. All requirements for issue of E-way bill will be the responsibility of the bidder.

8.0 TERMS OF PAYMENT

- 8.1 Payment shall be released within thirty days from the date of receipt of bills complete in all respects and without any discrepancies after submission of requisite proofs of successful completion of the work as per work order.
- 8.2 Payment will be subject to the conditions as mentioned in the clauses under Taxes and Duties. While making the payment, statutory deductions as applicable, shall be made by BHEL.
- 8.3 Successful bidder shall be required to furnish the EFT Details upon selection on its letter head as per Annexure IX.

9.0 PENALTY - QUALITY

9.1 If the final product does not match the quality and specifications mentioned, BHEL will not be obliged to accept the particular item(s) or service(s) as applicable. BHEL reserves the right to impose maximum penalty @10% of the cost of fabrication in case of any quality issue.

10.0 PENALTY - DELAY

- 10.1 Any delay in completion of the job w.r.t. Schedule given under, will invite imposition of penalty @ 2% per day or part thereof subject to a maximum of 10% of the total price.
- 10.2 The penalty shall be levied on the value of goods which have been delayed. Value of Goods delayed shall be derived on pro-rata basis from total order value. However, in absence of the stall readiness or major item(s) impacting upon the entire stall by the inauguration time of the exhibition, no charges would be payable irrespective of portion of work completed and the Security Deposit would stand forfeited. In case of any amendment/revision, the LD shall be linked to the amended/ revised Work Order value.
- 10.3 In case of LD recovery, applicable GST shall also be recoverable from the Contractor.
