The contractor shall guarantee that the equipment being supplied under this contract shall be new and of first quality workmanship and equipment / material supplied and services rendered (if applicable) shall be guaranteed to be free from all defects and faults in design & engineering, material, workmanship & manufacture and in full conformity with the Purchase Order / Contract, Technical Specifications & approved drawings / data sheets, if any, for 400kV & Below rating Isolators - for 18 months from the date of last delivery OR Twelve (12) months from the date of Taking Over/Completion of Facilities*, whichever is later.

*Taking over / Completion of facility: For purpose of guarantee, date of taking over/ completion of facilities is fixed as
