- a) **Clarification regarding submission of EMD**

**Existing EMD Clause:**

**1. EARNEST MONEY DEPOSIT (EMD)**

- a) Earnest Money Deposit (EMD) of the following values by way of Demand Draft or e-payment shall be furnished by the bidders.
- b) A one Time EMD of ₹2,00,000/- (Rupees Two Lakhs only) shall be paid by the bidders for quoting against any or all of the rate schedules covered against this Tender.
- c) The EMD will be accepted only in the following forms.
  - i. Cash deposit as permissible under the extant Income Tax Act (before tender opening)
  - ii. Electronic Fund Transfer credited in BHEL account (before tender opening)
  - iii. Banker's cheque/ Pay order/ Demand draft, in favour of BHEL (along with offer)
  - iv. Fixed Deposit Receipt (FDR) issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
- d) Bids submitted without EMD will be rejected out rightly and their offers will not be considered for further evaluation.
- e) MSE benefits (exemption from EMD only for Micro & Small) will be provided in case of submission of Valid UDYAM Registration Certificate.
