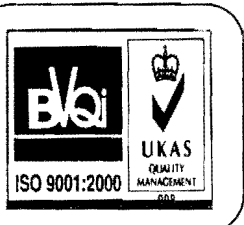
Following changes have been made in tender enquiry: -

1. BOQ/ Quantity for evaluating bidders shall be as provided in NIT (no change).
2. Duration of Framework Agreement (FA) shall be 24 months for placement of orders by respective locations/ units during validity of FA.
3. Quantity variation is +/-10 % of tender quantity.
4. BHEL reserves the right to further extend the FA (as per BHEL requirement), on mutual consent.
5. Prices shall remain firm till validity of FA or orders placed through FA whichever is later.
6. Performance monitoring is in lieu of penalty for resolution (SLA)/ LD clause.
7. BHEL reserves the right to short close the FA (i. e. no further POs shall be placed) and already placed existing/ active POs (placed against FA) shall continue to be honoured by the vendor till completion of the contract.
8. The Bank Guarantee shall be initially valid for (2 years and with additional two months as claim period) duration of FA and shall be extended till all contractual liabilities are fulfilled against FA and orders placed through these. Bank Guarantee value shall be 5% of tendered tentative quantity and shall remain unchanged for any subsequent variations in quantity (+/-10 %). BG shall be liable to forfeiture as per terms of clause 11 of NIT. BG shall be returned after successful completion of contracts placed under FA.
9. The orders shall be placed by resp. units for time frame (in months), tentatively as specified in NIT. However, for all the orders to close on a particular date, the order of some units may contain fraction of a month. The payment for fractions shall be made as per payment terms on pro-rata basis.

Pre-bid meeting venue shall be held on 05/Oct/2017 1430 hrs. at Main conference room, PPEI Bldg., Plot No. 25, Sector-16A, BHEL-PEM, Noida. You are requested to depute your representative for attending the same.
