1.0	A. The bidder should have engineered/ got engineered, supplied, erected, tested and commissioned vertical cylindrical storage tank, which is in successful operation in at least one (1) Unit of capacity 600 MW or above for a minimum period of one (1) years as on 01.07.2020. OR B. The bidder should have engineered/ got engineered, supplied, erected, tested and commissioned vertical cylindrical storage tank of minimum effective capacity 750 m3 in at least two (2) no. of thermal Power units of 500 MW or above, working satisfactorily for a minimum period of two (2) years within last 7 years as on 01.07.2020.
2.0	If the bidder does not possess the credentials mentioned at Clause No. 1.0 above, they may alternatively submit credentials establishing that they have engineered/ got engineered, supplied, erected, tested and commissioned at least one (1) number of vertical cylindrical storage tank of minimum effective capacity 200 m3 or more. The system/tank should have been in successful operation for at least one (1) year as on 01.07.2020 .
3.0	Bidder has to submit following supporting documents meeting above mentioned pre-qualifying requirement Copy of performance certificate (in English) from end user along with copy of related Purchase Order (PO) or Letter of intent (LOI) or Letter of Award (LOA) or Work Order (WO) in support of credentials above.
4.0	Bidder shall submit all necessary data such as type, design, make, capacity, duty conditions, date of commissioning/ operation etc. to substantiate technical parameters specified in PQR, if the same is not mentioned in performance certificate/purchase order.
5.0	Bidder to submit all supporting documents in English. If documents submitted by bidder are in language other than English, a self-attested English translated document should also be submitted.
6.0	Minimum one (1) no. PO/ LOI/LOA/WO shall be submitted which should not be more than seven (7) years old, for establishing continuity in business. This is over and above the requirement of PO/ LOI/LOA/WO mentioned at Sl. no. 2.0 above.
7.0	Notwithstanding anything stated above, BHEL / WBPDCS reserves the right to assess the capabilities and capacity of the bidder / sub vendors to perform the contract, should the circumstances warrant such assessment in the overall interest of BHEL / WBPDCS.
8.0	Consideration of offer shall be subject to customer's approval of bidders.
9.0	After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all the other terms of the tender.
10.0	The bidders approved by WBPDCS for the supply of MISCELLANEOUS TANKS (SITE FABRICATED) for 1x660 MW WBPDCS Sagardighi TPP Extension Unit No. 5 Project need not submit credentials as specified in this document (Clause No. 1.0 or 2.0).
