AA) AMENDMENT IN Clause No 9.iii, 9.IV.iii and Clause No 9.IV.iv of NIT:

Clause No , 9.III, 9.IV.iii and Clause No 9.IV.iv of NIT are amended as below:

Existing clause

9.III 'Assessment of Capacity of Bidder':

Assessment of Capacity of Bidder' is based on the Maximum number of packages for which a vendor is eligible, considering the performance scores of similar packages, as below:

Max number of packages P_{Max} = (R_{BHEL} - 60) divided by corresponding value of 'L', i.e. (RBHEL-60)/L

Note:

- In case the value of P_{Max} results in a i). fraction, the value of P_{Max} is to be rounded off to next whole number
- For $R_{BHEL} = 60$, $P_{Max} = 1'$
- iii). For $R_{BHFI} \ge 80$, there will be no upper limit on P_{Max}

The Bidder shall be considered 'Qualified' as per 'Assessment of Capacity of Bidder' for the subject Tender if $P \leq P_{Max}$

(Where P is calculated as per clause 'I' above) In addition to above, in case contractor fails to score more than 5 (five) marks in the scaled down scores of HSEPES for "more than 2 months in a period of 6 months preceding and including the cut-off month in any single package", the contractor shall be considered disqualified for ongoing tender(s) of BHEL. Qualification of bidder for further tendering process shall be subject to qualifying this condition in addition to qualifying requirements mentioned in PQR. Bidders who did not qualify this condition shall not be considered under the provisions of clause 9 IV (iv) of NIT.

9.III 'Assessment of Capacity of Bidder':

Assessment of Capacity of Bidder' is based on the Maximum number of packages for which a vendor is eligible, considering the performance scores of similar packages, as below:

Max number of packages P_{Max}= (R_{BHEL} - 60) divided by corresponding value of 'L', i.e. (R_{BHEL}-60)/L

Note:

- I.—In case the value of P_{Max} results in a fraction, the value of P_{Max} is to be rounded off to next whole number
- $H.-For R_{BHEL} = 60, P_{Max} = 1'$

The Bidder shall be considered 'Qualified' as per 'Assessment of Capacity of Bidder' for the subject Tender if P ≤ P_{Max}

(Where P is calculated as per clause 'I' above) In addition to above, in case contractor fails to score more than 5 (five) marks in the scaled down scores of HSEPES for "more than 2 months in a period of 6 months preceding and including the cutoff month in any single package", the contractor shall be considered disqualified for ongoing tender(s) of BHEL. Qualification of bidder for further tendering process shall be subject to qualifying this condition in addition to qualifying requirements mentioned in PQR. Bidders who did not qualify this condition shall not be considered under the provisions of clause 9 IV (iv) of NIT.

A Bidder shall be considered 'Oualified' as per 'Assessment of Capacity of Bidder' for the subject Tender if $R_{BHEL} >= 60$ (Irrespective of **HSE Score**)

Note: All associated clauses of the tender shall be read accordingly.
