Oil from drums to be transferred in storage tank and filtration to be carried out to achieve the required BDV/ withstand value. This treated oil to be filled in the transformers and auxiliaries. However, for low capacity transformer, a separate storage tank for mass filtration may not be required	Contractor shall arrange 2 number storage tank of approx. 10 kilo litre capacity each, internally sand blasted and with one coat of oil resistance paint. Oil from drums to be transferred in storage tank and filtration to be carried out to achieve the required BDV/ withstand value. This treated oil to be filled in the transformers and auxiliaries. However, for low capacity transformer, a separate storage tank for mass filtration may not be required.
