1. Clarifications/ Corrigendum to Special terms and conditions/ Additional terms and conditions

Sl No.	Clarifications/ Corrigendum to Special terms and conditions/ Additional terms and conditions
1)	Applicable for supply portion for BOQ item no. 1.01 to 1.21
a)	The <u>materials of other than Indian Origin</u> is to be delivered by the bidder directly at Biratnagar, Nepal. The destination address is already specified in the NIT. The charges for custom clearance, freight & insurance or any other charges/costs involved in transportation of the materials and other associated costs from the factory/ works for the said destination is to be borne by bidders themselves. Unloading at BHEL destination Biratnagar, Nepal will be done by BHEL.
b)	<u>The material of Indian origin</u> is to be delivered by bidder at Biratnagar, Nepal at the destination address already specified in the NIT. BHEL will complete the custom clearance at Jogbani, Bihar at Indo Nepal Border and unloading at Biratnagar. The bidder has to ensure that the material is delivered through the same vehicle to Biratnagar, Nepal after custom clearance by BHEL. The charges for freight & insurance or any other charges/ costs involved in transportation of the materials and other associated cost from the factory/ works for the said destination is to be borne by bidders themselves. However, bidder should quote the custom clearance charges in <u>Annexure-XVII</u> . This will be used In case BHEL opts that customer clearance is required to be done by the bidder. These Customs Clearance Charges shall also be used purpose of tender evaluation.

2)	<p>Note 1 in Clarification for SI no. 05 of "Special Terms & Conditions" i.e Clause No. 02 of GTC stand deleted and Point no 3 is added as under:-</p> <p>For Purpose of Tender Evaluation, Prices (as per Annexure XVII) is to be quoted by Indian Bidder for Customs Clearance.</p> <p>a) Cost of Customs Clearance Charges shall be arrived by BHEL by multiplying the % (as quoted by bidders in Annexure XVII) with the Prices(Excluding applicable taxes as per NIT) quoted by bidder in priced Bid- BOQ for items of Indian origin as indicated in Annexure XVII. In case Indian Bidder does not submit the Annexure XVII or does not fill any % in Annexure –XVII or fails to mention item No for Item of Indian Origin, It shall be considered that Bidder has quoted the charges as Nil i.e without any extra cost to BHEL.</p>
3)	<p>Concessional Customs duty is applicable for the Project, BHEL will provide the documents for concessional Custom Duty. BHEL will reimburse the Customs Duty to bidder on submission of receipt/ necessary documents to BHEL for onward submission of documents to customer for the purpose of claiming reimbursement.</p>
4)	<p>SI no 5 of Special terms and conditions (i.e clause pertaining to clause no 2 of GTC) is modified as under:-</p> <p>The purchase order shall be placed on Ex- Works basis for Indian Vendors for materials of Indian Origin.</p> <p>For overseas Vendor/ or for materials other than Indian origin being supplied by Indian bidder, the order is proposed to be placed on CIF basis. However, BHEL reserves the right to convert the order on FOB also. The evaluation of bids shall be done on delivered cost to BHEL.</p>

9)	<p>For the purpose of cl no 23 of Additional terms and conditions i.e clause pertaining to additional performance guarantee (if applicable) , Bank Guarantee shall be required for 10% of Total PO Value (Excluding applicable taxes as per NIT) of supply portion i.e price of BOQ item no. 1.01 to 1.21 and 2.12 to 2.32 of BOQ</p>


