Necessary inventory is required to maintain at project site for fast progressing project and avoid interface issues with civil agencies.</p> <p>2. Manufacturing time of Gratings, HT bolts, deck sheets, studs are procured based on advances of 25 % to 50 % to approved agencies of NTPC / BHEL against order to expedite fast delivery (Minimum 45 to 60 days from advances paid) + delivery one week to project site.</p> <p>3. As stated above, even liners are also to be ordered SAIL in 45 days schedule for delivery. If BHEL is expecting competitive rates henceforth bidder has to procure from manufacturer to get god prices by paying advances and good material.</p> <p><u>Following payments break up of 60 /40 is not feasible to procure directly from manufacturer and good quality products - Rates under 60 % is almost 25 % low cost to actual procurement cost.</u></p> <p><u>We request BHEL TO CONSIDER THE REQUEST FOR 80 % / 20 % so that obligations of contract can be met by timely completing procurements.</u></p>	Tender conditions shall prevail.
