With reference to the above, Following clarifications/ Amendment in NIT may please be noted:-

1. Clarification against point no. 01 to 09 and Annexure-XVII of Corrigendum-03 Dated 27.11.2021 may be treated as withdrawn and Clarifications are modified as below: -

Sl No.	Clarifications/ Corrigendum to Special terms and conditions/ Additional terms and conditions
1)	<p><u>Applicable for supply portion for BOQ item no. 1.01 to 1.21</u></p> <p>The material is to be delivered by bidder at Indo Nepal Jogbani-Biratnagar Border. BHEL will complete the custom clearance at Indo Nepal Jogbani Border. The bidder has to ensure that the material is delivered through the same vehicle to Biratnagar, Nepal after custom clearance by BHEL.</p> <p>BHEL will complete the unloading at Biratnagar. In case Bidders wants to bring the material through Nepal border other than Jogbani, Indo Nepal Border, the bidder has to arrange the custom clearance and bear all the associated cost for the same.</p> <p>The charges for freight & insurance or any other charges/ costs involved in transportation of the materials and other associated cost till the said destination is to be borne by bidders themselves.</p>
2)	<p>1% custom duty is applicable in the project. In case of custom clearance by BHEL at Indo Nepal Border Jogbani custom duty will be paid by BHEL. The vendor will provide the necessary documents in advance to BHEL for custom clearance by BHEL.</p> <p>In case, vendor opts for custom clearance at any other Nepal Border, 1% custom duty will have to be deposited by Vendor on behalf of BHEL /Customer. BHEL will reimburse the 1% Custom Duty after submission of necessary documents to BHEL.</p>
3)	<p>Sl no 5 of Special terms and conditions (i.e clause pertaining to clause no 2 of GTC) is modified as under:-</p> <p>The purchase order shall be placed on Ex- Works basis for Indian Vendors for materials of Indian Origin.</p>

	For overseas Vendor/ or for materials other than Indian origin being supplied by Indian bidder, the order is proposed to be placed on CIF basis. However, BHEL reserves the right to convert the order on FOB also. The evaluation of bids shall be done on delivered cost to BHEL.
4)	The word DAP (i.e Delivery at Place) wherever appearing in NIT is to be read as FOR destination basis. However in case bidder becomes L1, BHEL may ask the bidder to bifurcate the unit prices to separately indicate the ex-works/ FOB/F&I etc.
5)	For purpose of SI no 8 of STC (i.e cl pertaining to cl no 7 of GTC of supply portion & 9 of GTC of ETC portion) the word "total ex works value" are to be read as "Total PO value (Excluding Taxes)" i.e Performance Bank Guarantee Shall be required for 10% of Total PO Value (Excluding Taxes).
6)	SI no 16 of Special terms and conditions (i.e clause pertaining to sl no 40 of GTC). the word "Ex-works prices" may be read as Prices.
7)	The word "Total Ex works value/ Total Exworks prices" in clause no 4 of Additional Terms and conditions to be read as "Total PO value (Excluding Taxes)".
8)	For the purpose of cl no 23 of Additional terms and conditions i.e clause pertaining to additional performance guarantee (if applicable) , Bank Guarantee shall be required for 10% of Total PO Value (Excluding applicable taxes as per NIT) of supply portion i.e price of BOQ item no. 1.01 to 1.21 and 2.12 to 2.32 of BOQ
9)	Additional clarification regarding Taxes & Duties:- In case of any bidder other than Indian / Nepali bidder, If GST is applicable on the Type Test Charges, it shall be borne by BHEL and shall be deposited by BHEL on reverse charge mechanism basis.
10)	In case of foreign bidder becomes L1, the Purchase Order will be executed as third country export basis.


