**15.64** For the execution of work agency shall deploy welders. Deployed IBR welder/specialised welder\* shall undergo welder training program by BHEL on chargeable basis. Charges towards welder training program shall be Rs. 10,000/- per welder which shall be deducted from agency's RA Bill. Welding electrode for welder training shall be arranged by agency. BHEL shall provide other facilities and technical support at site during welder training.

\*Specialised welder: Titanium Welder and C276 Welder.

All other Terms and conditions of the Tender Specification shall remain unaltered unless expressly amended by BHEL in writing.
