**AA) Heading of Clause no. 2.1.10 ' Model / Age of Crane' of Chapter-II 'Scope of Works and Technical Specifications' of "Volume-IA-Technical Bid" has been amended as below:**

Existing Clause no. 2.1.10 ' Model / Age of Crane'	Amended as
The crane shall not be older than 15 years as on date of deployment. The manufacturer's certificate, invoice copy or relevant documentary proof shall be furnished with bid documents for evaluation of bid. Before deployment of the crane at site bidder has to submit a set of same documents of crane to BHEL site in-charge to confirm /verify that, the crane going to be deployed shall not be older than 15 years. Only after receipt of confirmation from BHEL site in-charge, bidder can deploy the crane. CRANE MUST BE IN THE POSSESSION OF BIDDER AT THE TIME OF OFFER SUBMISSION.	<b>Manufacturing year for crane model offered shall not be more than 15 years as on latest date of submission of offer.</b> The manufacturer's certificate, invoice copy or relevant documentary proof shall be furnished with bid documents for evaluation of bid. Before deployment of the crane at site bidder has to submit a set of same documents of crane to BHEL site in-charge to confirm /verify that, the crane going to be deployed shall not be older than 15 years.
