CPC Tender No. BHEL/CPC/KGN/CHM/25/036 for the work of “Balance construction work of 1 No. 180 Mtr. height RCC Single Flue Chimney of U#1&2 complete in all respect including Chimney RCC Wind Shield, Fabrication & Erection of Steel Flue Cans, Installation of Borosilicate Glass Block Lining on Inner Surface of Steel Flue Can, Erection of shop Fabricated Structural Platforms, Installation of Electrical items in conformity with the approved layout etc. to complete the chimney in all respect but excluding pile & Raft, of FGD system at 4 X 210 MW, Stage-I & 3 X 500 MW, Stage-II NTPC Kahalgaon, Bihar”.
