Name of Work: Levelling and Grading works including construction of embankment along with lining, toe drains etc., Storm Water Pond and Storm Water Pump at 3 x 800 MW NLC TALABIRA TPP (NTTPP), Jharsuguda, Odisha, INDIA.

Package-A- Levelling and Grading works including construction of embankment along with lining, toe drains etc., Storm Water Pond and Storm Water Pump in the Northern side of the entire plant area excluding area along compound wall as demarcated in Plot Plan.

Package-B- Levelling and Grading works including construction of embankment along with lining, toe drains etc., Storm Water Pond and Storm Water Pump All levelling and grading works in the Southern side of the entire plant area excluding area along compound wall as demarcated in Plot Plan.

'OR' B.2.2 : Civil works involving earthwork for a volume of minimum of 9,34,310 CUM within common period of 12 consecutive months in cumulative of one running/completed contract.	Clause B.2.1 requires execution of a minimum volume of 14,01,460 Cum within a 12-month period in cumulative of 2 contracts, and Clause B.2.2 requires 9,34,310 Cum within a 12-month period in one contract. We note that the total BOQ quantities in each of Package A and Package B are significantly lower than the above requirements. Kindly clarify whether these criteria are applicable as mentioned, or if they will be revised in accordance with the actual scope and quantities of each package.
