Purchaser reserves the right to recover from the Seller/ Contractor, as agreed liquidated damages and not by way of penalty, a sum equivalent to half (½) percent and applicable GST thereon, of the total Mandatory Spares contract price excluding GST per week or part thereof, subject to a maximum of ten (10) percent of the total Mandatory Spares contract price excluding GST, if the Seller/ Contractor fails to deliver any part of the ordered Mandatory Spares goods/stores within the period stipulated in the Order/ Contract.

2. **Guarantee Terms:** As per Cl. No. 10 of GTC on GeM for the bid. However, time period shall be as under:

**For Main Supply:** Guarantee & Warrantee time period shall be 18 months from the date of last supply in the Main Supply scope.

**For Mandatory Spares:** Guarantee & Warrantee time period shall be 18 months from the date of last supply in the Mandatory Spares Supply scope.

3. **Other special major condition: -**

- Bank Guarantee submission shall be as per cl. No. 7 of GeM GTC with initial validity of 26 Months. Further, extension if any shall be as per GeM Terms. However, proportionate value of BG can be reduced on elapse of 2 months from expiry of Guarantee & Warrantee period of Main Supply Scope/Mandatory Spares Scope (as applicable).
