

## Corrigendum 1 dated 24.09.2025 to Tender Ref. No. PSSR-BOP-ENQ-ENRSEZ-001 for 2x660 MW Ennore SEZ- Sewage Treatment Plant

## A. The following clauses in the Tender Specification are modified as below:

## B. Some of the Bidders had asked queries in the published Tender Specification. The clarifications issued by BHEL are furnished below:

1	Since the system is designed by M/s Pennar, can we assume that the process guarantees will be demonstrated during PG tests as per M/s Pennar's approved procedure?	M/s Pennar's approved procedure shall be followed in totality.
2	As per MDL, many documents are under <i>Resubmission Code</i> and several are still due for first submission. This will require additional time to complete engineering activities apart from supply, commissioning, and PG test schedules. Please confirm.	These 'Resubmission Code' document shall be submitted by L1 bidder after award of contract for further approval from BHEL and/ or customer as applicable. Any time delay on account of this shall not be linked with time schedule for supply, erection, commissioning and PG tests.
3	As the sub-vendor and categorisation list is already approved, kindly clarify how we should proceed if we intend to propose a new vendor.	Bidder to follow the earlier approved sub vendor list and categorisation plan. If any new sub vendor will propose by any bidder then the below addressed points shall be taken care by bidder. a) Bidder can also go with other make/ sub-vendor items for which the modification work on existing civil foundation to be taken care by bidder at site. b) The make of items shall be as per approved sub vendor list. However, any additional sub-vendor required the same shall be subject to BHEL/ customer approval during detailed engineering without any commercial/ delivery implication to BHEL/ customer.
4	For equipment/instrument datasheets and drawings already approved for a particular make, do we need to follow the same vendor, or can we propose an alternative vendor from the approved list (or a new vendor)?	Bidder to follow earlier approved make and data sheet. For a special case (in case of no other option left) If any change in earlier approved document required then the reply given in sl no 3 above shall be followed.
5	Kindly provide clarity on the free-issue material arrangement.	Materials already supplied for STP package earlier, shall be provided to the new vendor for erection from BHEL stores free of cost. Further new vendor has to draw material from stores and further do the needful to facilitate for erection.
