Clause No. 3.0 of TCC	MANPOWER REQUIREMENT The bidder shall have at least 20 number of experienced (minimum 2 years) qualified surveyors on their rolls/ contract who have conducted identical Customer Satisfaction/ Perception Surveys with reputed organizations like the ones mentioned in the Qualifying and Eligibility criteria. The bidder shall provide the list of such qualified surveyors along with their offer.	MANPOWER REQUIREMENT The bidder shall deploy only experienced (minimum 2 years) and qualified surveyors who are on their own roll or directly engaged by them on contract and who have conducted identical Customer Satisfaction/ Perception Surveys with reputed organizations like the ones mentioned in the Qualifying and Eligibility criteria. The bidder shall provide the list of such qualified surveyors along with their credentials as and when demanded by BHEL.
