- 1) Addition of Clause no. C (28) and Annexure VI as follows:
 - a) The Earnest Money Deposit (EMD) of **Rs 2,520/-** only in the following forms in favour of BHEL, payable at New Delhi, must be submitted in a separate envelope:
 - a) Cash deposit as permissible under the extant Income Tax Act (before tender opening)
 - b) Electronic Fund Transfer credited in BHEL account (before tender opening)
 - c) Banker's cheque/ Pay order/ Demand draft, in favour of BHEL (along with offer) However, the EMD amount shall be refunded after successful placement of Work Order.
 - b) Tender not accompanied with EMD will not be accepted except for MSE Suppliers as detailed in below clause.
 - c) MICRO AND SMALL ENTERPRISES (MSE):-
