**Sub: Corrigendum to Tender Enquiry for Hiring of DLY Taxis on Demand basis / Monthly basis for local & outstation journeys.**

Dear Sir,

With reference to our tender enquiry for Hiring of DLY taxis on demand basis / monthly basis for local and outstation journeys, following are the clarifications with respect to terms & conditions of the tender and the contract as well.

**1. Micro and Small Enterprises (MSE)**

Any bidder falling under MSE category, shall furnish the following details and submit documentary evidence/Government certificate etc. in support of the same along with their techno-commercial offer.

Note: If bidder does not furnish the above, offer shall be processed construing that the bidder is not falling under MSE category.

- MSE Suppliers can avail the intended benefits only if they submit attested copies of either Udyog Adhaar or EM-II certificate having deemed validity (five years from the date of issue of acknowledgement in EM-II) along with attested copy of a CA certificate (format enclosed as Annexure-XVI) or valid NSIC certificate or along with the offer. Date to be reckoned for determining the deemed validity will be the last date of bid submission. Non submission of such documents will lead to consideration of their bids at par with other bidders. No benefits shall be applicable for this enquiry if the above required documents are not submitted along with offer.
- MSEs shall be exempted from payment of earnest money deposit (EMD) at the time of tender submission. However, there is no exemption of security deposit.
- Participating MSE quoting price within price band of L1+15% shall be considered for award of 30% of business volume if the MSE accepts L1 price in a situation where L1 price is from someone other than MSE. In case of more than one such MSE, MSE with

lowest price shall be given the first option to match the L1 price. However, MSEs owned by Scheduled Caste or Scheduled Tribe entrepreneurs shall be given the preference for matching the L1 price irrespective of their standing in comparative statement of MSE bidder within price band of L1+15%.

2. Sl. No. 1 of Annexure XIV (checklist) where it is stated that "EMD is acceptable in the form of Pay order or DD in favour of BHEL" is to be corrected and read as:


"the payable EMD amount of ₹ 1,00,000.00 (Rupees One Lakh only) is to be deposited only by way of NEFT in favour of BHEL and a copy of the acknowledgement of payment of EMD is to be enclosed in a separate envelope". The bank account details of BHEL for NEFT is enclosed as Annexure XV of the tender enquiry document.

3. The last date of submission of complete tender bids has been extended up to 1430 hours of 17.01.2018. The opening of tender shall be on same day at 1500 hours.


