**5.2 Past Experience:** The experience of having successfully completed similar jobs/services during last 7 year sending on last day of month i.e. 30-11- 2020 (previous to the one in which applications are invited) should be either of the following:

5.2.1 The bidder should have executed three similar jobs/services with contract business volume of each for one-year contract period; not less than an amount equal to ₹42.0 Lakhs.

OR

5.2.2 The bidder should have executed ~~three~~ two similar jobs/services with contract business volume of each for one-year contract period; not less than an amount equal to ₹52.55 Lakhs.

OR

5.2.3 The bidder should have executed ~~three~~ one similar jobs/services with contract business volume of each for one-year contract period; not less than an amount equal to ₹84.0 Lakhs.
