Sealed tender in two part bids were invited vide NIT 17: AA:NOI:ADMN.: Drone Imagery:112:2020-21 Dated 27.10.2020 for rate contract for drone imagery of BHEL lands and properties located across India. The following may please be noted by all the bidders as modifications in Tender:

1. Clause no. 22. a) in "Payment Terms" on page no. 7 of Section D: "General Terms & Conditions" in the NIT, shall be modified as:

Only 80% payment shall be made by the respective unit/office/site for which the work is fully completed as certified by the Engineer-in-Charge/Township In-charge/Estate Officer. The remaining 20% payment shall be released by the respective unit/office/site, only after confirmation of 100% work completion (for all the sites) from Corporate Office.

2. The last line EMD clause, no 27. a) on page no. 8 of Section D: "General Terms & Conditions" in the NIT, shall be modified as:

Tender not accompanied with EMD will not be accepted except for MSE Suppliers who have submitted valid NSIC certificate along with tender's Techno-commercial Part I- Bid.

3. The following clause shall be added as clause no. 39 on page no. 10 of Section D: "General Terms & Conditions" in the NIT:

MICRO AND SMALL ENTERPRISES (MSE):-

- a) MSE Supplier can avail the intended benefits only if they submit along with offer, attested copies of either Udyog Aadhar or EM-II certificate having deemed validity (five years from the date of issue of acknowledgement in EM-II) or the valid NSIC certificate or EM-II certificate along with attested copy of a CA Certificate (format enclosed as **Annexure- V**) where deemed validity of EM-II certificate of five years has expired applicable for the last audited financial year. Date to be reckoned for determining the deemed validity will be the date of bid opening. Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are not submitted before price bid opening.
- b) Participating MSEs quoting price within price band of L1 + 15 % shall be considered for award (of complete scope of work) as per prevailing rules, by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE. In case of more than one such MSE, MSE with lowest price shall be given the first option to match the L1 price. However, MSEs owned by the Women entrepreneurs (as per rules) shall be given the preference for matching the L1 price irrespective of their standing in comparative statement of MSE bidders within price band of L1 + 15%. Similarly, MSEs owned by the Scheduled Caste or the Scheduled Tribe entrepreneurs shall be given the preference for matching the L1 price irrespective of their standing in comparative statement of MSE bidders within price band of L1 + 15%.
