## Corrigendum

**Reference:** Tender Enquiry no. 2425-038E dt 22.08.24 for supply of "HSFG Fasteners Rate Contract -2"

#### Following corrigendum are issued for subjected tender:

(A) It is found that the quantity mentioned in Part-1 (Techno commercial bid) is different from quantity mentioned in Price bid (BoQ format) & in tender terms and conditions. However, Quantity mentioned in Price bid (BoQ format) & in tender terms & conditions is correct.

Therefore, in Part 1 (Techno commercial bid) of tender documents, Qty for different items for which rates are invited are to be referred from quantities indicated in Price bid (BoQ format) of tender documents. In this regard, **revised Part-I** (**Techno commercial bid**) is attached.

It is clarified that Qty in Part-1 (Techno commercial bid) submitted by bidder shall be considered as revised qty given in this corrigendum in the event of submission of old Part-1 (Techno Commercial bid) by any bidder.

#### (B) Clause No. S13 of Special Terms & Conditions of tender shall be read as below:

## **S13 COMPLIANCES**

- a. Bidder has to manufacture and supply the material complying all the latest applicable Notifications / Orders issued by the Bureau of Indian standards (BIS) or any Government agency.

- f. If any MSE vendor is unable to get the BIS License by BIS Implementation date, then BHEL may go for Cancellation of Pending orders.
