 BHEL on quarterly basis. Any penalty, if applicable due to delayed payment of DSM charges to SLDC, shall be borne by QCA.

Corrigendum: Clause no: 4 of Special conditions of contract of NIT (page no: 13) shall be read as

- (a) DSM Charges in case of deviation beyond the permissible limits (as per TSERC Regulations in existence and amended from time to time) shall be borne by QCA.
- (b) However, reasons for deviations beyond permissible limits which are attributable to BHEL shall be excluded from QCA responsibility and borne by BHEL. In such cases, QCA shall pay the entire DSM charges as claimed / levied by SLDC and DSM charges attributable to BHEL shall be reimbursed on quarterly basis.
- (c) Any penalty, if applicable due to delayed payment of DSM charges to SLDC, shall be borne by QCA.
- (iii) Clause no: 5 of Special conditions of contract of NIT (page no:13)

 DSM charges shall be paid on quarterly basis by submitting duly supported documents/reports for the reason of deviations, invoices, payment proofs and statements provided by SLDC.

DSM charges attributable to BHEL shall be reimbursed on quarterly basis by submitting duly supported documents/reports for the reason of deviations, invoices, payment proofs and statements provided by SLDC.

- (iv) Clause no: 7 of Special conditions of contract of NIT (page no:13)

 Forecasting Performance: Accuracy guarantee against forecasting shall be 85% as per TSERC Regulations, 2018 in existence and amended from time to time.

 Corrigendum: Clause no: 7 of Special conditions of contract of NIT (page no: 13) is considered to be deleted.
- (v) Clause no: 8 of Special conditions of contract of NIT (page no:13)

 Penalty: For every 1% reduction in accuracy on monthly basis, liquidated reduction equivalent to 1% of QCA fee charges shall be levied on monthly basis for such reduction. Maximum liability of QCA shall be 10% of monthly QCA fee paid for respective month. Blocks for which real time SCADA data is unavailable due to issues at plant end and blocks in which maintenance/breakdown was done and the same was not conveyed to QCA shall be excluded from the calculation.
