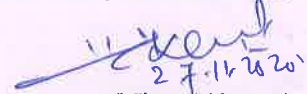

3	Annexure B of Technical Terms & Conditions / Specifications, Sl. No. 1 b	Sl.No. 1 b shall be read as: "Tender not accompanied with EMD/ EMD submitted in any forms other than the manner prescribed in the tender will not be accepted."
4	Annexure B of Technical Terms & Conditions / Specifications, Sl. No.1 (Earnest Money Deposit) ,paragraph	The paragraph shall be read as "The EMD will be refunded to the unsuccessful bidders within fifteen days of acceptance of award of order by the successful bidder(s)/ expiry of the validity of the bid, whichever is earlier.
5	Chapter-2,General Conditions of Contract (GCC)	Sl. No. 2.26.4 is added as "Invoice should be raised in the name of BHEL Corporate Office, BHEL House, Siri Fort, New Delhi – 110049."
