#### 5. Special condition:

- 1. Sub contracting or subletting is not allowed
- 2. **BHEL** reserves the right to terminate the contract by giving 15 days notice in writing in case the services are not found satisfactory and forfeit the security deposit
- 3. The party shall indemnify BHEL for all the losses / damages occurred during the operation of the contract.
- 4. **Arbitration**: If any time, any questions, disputes or differences what so ever arising out of or in any way concerning the contract between BHEL and the Contractors, the same shall be referred to the sole arbitrator i.e. General Manager, BHEL, ROD, Mumbai or nominee appointed by him in writing.. The award of the arbitrator shall be final and binding on both the parties.
- 5. Offer Validity: One month from date of Tender opening.
- 6. **Statutory Levies:** The contractor will pay all statutory liabilities of the workers and employees engaged by him and ensure that they are paid minimum wages as notified by the State Government from time to time and all other statutory laws shall be complied by the contractor.
- 7. **Workmen Compensation:** It is the sole responsibility of the contractor to insure his staff engaged in the BHEL Flats under Workmen Compensation Insurance Act against any unfortunate incidences / accidents while on duty.
- 8. **Risk Purchase / Penalty:** For the unsatisfactory / poor services and not redoing the job at its own cost, BHEL reserves the right to deduct 100% payment made towards the unsatisfactory job done and get the same done through another party at the cost and risk of the contractor.
- 9. Entire job is to be finished within 90 days from the issue of work order. There would be Penalty @ 5% per week of the contract value pro rata. It will be levied, if there is delay beyond the schedule completion period, subject to a maximum of 10%.
- 10. The Contractor shall indemnify and keep indemnified BHEL all losses, claims etc. arising out of any of his acts or out of the acts of his Contractors or associates or servants during the currency of the contract.

#### 11. Time Limit for Submission of Bills

The contractor shall make a claim for the services rendered under this contract to BHEL within (3)Three months of such service. If he does not prefer claim within the said period, he shall be deemed to have waived his right in the respect thereof and shall not be entitled to any payment on account thereof. Nevertheless, the accepting authority on written request can waive off this limitation and allow late submission of bills if the reasons for delay are found convincing and reasonable.

#### 6. EVALUATION CRITERIA:

There will not be RA. Bidders are requested to give their best possible offer. Offer should be firm. The offers will be evaluated on the basis of the total price basis (Ref Price Bid) as shown in the price bid. The qualified bidder who quotes lowest, will be referred as L1 and called for further process of award of work. Order will be placed on one party only. BHEL Reserves right to Negotiate with L1 party.

In case of tie for L1, name of parties who quoted lowest, will be written on individual chit, all chits will be folded and placed in box/pot. One of the party (preferably in alphabetical order) will be asked to pick one chit from the box/pot. The bidder whose chit is picked up, will be termed as L1 for further process.

#### 7. PAYMENT TERMS

- a. No Advance payment will be made.
  - Payment shall be made on completion of entire work, within 45 days through NEFT/RTGS on receipt of bill duly accompanied by satisfactory completion work certificate from BHEL representative. Payment will be based on actual measurement of work certified by BHEL representative. The joint measurement copy signed by representative of BHEL and contractor will be required.
- b. Pakka bill / Tax Invoice with GST number is must. The bill should be in name of Bharat Heavy Electricals Limited bearing GST No. 27AAACB4146P1ZF. The GST No. of bidder should also be written on the bill. The tax invoice should be GST compliant. The GST amount would be released once it is reflected on GST portal.
- c. The Contractor will be required to raise the Invoice for the services rendered. The Invoices will have to be raised according to the explicitly agreed rates and payment terms of the contract.
- d. Payment will be made online through NEFT/RTGS to contractor bank account within 45 days of submission of bill and its verification. Successful bidder must give bank details for eMandate in prescribed format.
- e. The contractor will have to produce invoices showing the tax elements separately.
- f. TDS as applicable will be deducted at source from the payment . In case the, TDS is not to be made, the contractor r will have to produce the exemption letter from the relevant authorities to this effect along with bill submitted for payment.
- g. The successful bidder shall furnish proof of GST registration with GSTN Portal covering the services under this contract. Registration should also bear endorsement for the premises from where the billing shall be done by the successful bidder on BHEL for this project/ work.
- h. In case of raising any Invoice/ Supplementary Tax Invoice (Debit / Credit Note) Bidder shall issue the same containing all the details as required as per applicable GST Act & Rules.
- i. Bidder shall comply with the Time limit prescribed under the GST Law and rules thereof for raising of the tax invoice.

- j. Bidder shall note that in case GST credit is delayed/ denied to BHEL due to delayed / non receipt of goods and /or tax invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons attributable to the bidder, GST amount shall be recoverable from the bidder along with interest levied / leviable on BHEL, as the case may be.
- k. Bidder shall upload the Invoices raised on BHEL in GSTR-1 within the prescribed time as given in the GST Act. Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by BHEL is denied or reversed subsequently as per GST Law , GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from the bidder along with interest levied / leviable on BHEL.

#### 8. Security Deposit

Security Deposit (SD): The Successful L1 bidder, within seven days of receipt of the notification of acceptance of LOI or before start of work (whichever is earlier), deposit Security deposit @ 5 % of Contract value.

- D. The order will be finalized on one party only.
- E. GST will be payable as per actuals
- F. The rate quoted by bidder shall be firm till completion of entire job as per tender document.
- G. Price format shall not be changed by bidder in any case and it may lead to rejection of their offer
- H. In case of discrepancy between amount quoted in words and figure, the amount quoted in words will be considered.
