Note:

1	(a) If, in the price structure quoted for the required goods/ services/ works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
	(b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
	(c). If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
	(d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date upto which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
2	Price bid should be free from correction, overwriting, using corrective fluid etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature (s) of persons(s) signing the bid else bid shall be liable for rejection.
3	The bidder is not allowed to change price bid after the due date, within the validity period.
4	Discounts/revised offers given after Part-1 bid opening is not acceptable.

5	In case of tie the course of action is as below:-
a	In course of evaluation if more than one bidder happens to occupy L-1 status, then effective L-1 will be decided by soliciting discounts from the respective L-1 bidders.
b	In case if more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s).
c	Ranking will be done accordingly. BHEL's decision in such situation shall be final & binding.
6	The price bid should be duly sealed and signed.
