- i. Amount to be mentioned clearly in Indian form of international numerals.
- ii. No corrections/alterations are permitted while mentioning the amount.
- iii. Amount to be written in both figures and words. If there is any difference between figures and words, the words will prevail.
- iv. Bids lower than **Reserved (Minimum) Rent Amount per month for the quarter** shall be rejected. Bidder shall quote cluster wise (1 to 29).
- i. Tender shall be awarded to Highest Bidder(H1) for respective Cluster.
- ii. No splitting of Quarters shall be accepted in one cluster. Bidder shall be quote for total number of Quarters in one Cluster.
- iii. If bidder is not quoted for all type of quarters in respective Cluster, bid shall be liable to rejected.
- vii. In case of course of evaluation, if more than one bidder happens to occupy H-1 status, effective H-1 will be decided by soliciting higher rent from the respective H-1 bidders. In case more than one bidder happens to occupy the H-1 status even after soliciting higher rent, the H-1 bidder shall be decided by a toss/draw of lots, in the presence of the respective H-1 bidder(s) or their representative(s). Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.
