PREAMBLE OF PRICE BID

1.0. This Price Bid consists of three Schedules:

1.1 Schedule A

Schedule A consists of single Annexure:

1) Annexure-I includes items based on GST Compliant DSR-2012, Rate analysis & previous work order.

Bidders are requested to quote their rate in Percentage above/below/at Par for Annexure-I.

1.2 Schedule B

Schedule B gives the details of free issue materials given by BHEL.

1.3 Schedule C

Schedule C gives the details of Tools & Tackles provided by BHEL on Chargeable Basis.

2.0 The work to be carried out under the contract shall, except as otherwise provided in tender conditions, include all labour, materials, tools, plant, equipment, and transport which may be required in preparation of and for full & entire execution and completion of the Works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on materials, carriage and cartage, carrying in return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion as aforesaid in accordance with good practice and recognized principles as laid down in Technical Specification & elsewhere in Tender Specification.

3.0 The price bid should not contain any condition. Conditional price Bids shall be summarily rejected.

4.0 The bidder should not leave any column blank in Price Schedules.

5.0 Price Quoted shall include all taxes, & duties except GST.

6.0 **Unless otherwise specified in the items involving cement or reinforcement steel, these items shall be issued free of cost by BHEL.**

Note:

1. A logbook shall be maintained to record deployment of vehicle/machine for the above said items.
2. RTO registration alongwith other RTO papers of the vehicle/machine and driver shall be submitted by the contractor to the department for verification prior to actual deployment.
3. The contractor may be required to deploy vehicle/machine on all days including sundays and holidays without extra cost to BHEL over and above the awarded rate.
4. The contractor shall engage only those vehicles/machines which are in good running condition.
5. In spite of written instruction by Engineer-in-charge, if the contractor fails to deploy vehicle/machine, penalty shall be imposed at 1.25 times the awarded rate of the item.
6. Mere presence of vehicle/machine without availability of driver, fuel etc. shall not be considered as 'deployment' under any circumstance by the department. The vehicle/machine should, in any way be in operational condition otherwise penalty shall be imposed @1.25 times the awarded rate of the item.
7. All repair work to the above-said vehicle/machine shall be in the contractor's scope. To minimize the downtime, the contractor shall keep in his custody sufficient spares/components. If the services are not restored within 4 hours, penalty for excess break-down period beyond 4 hours shall be imposed on the contractor in proportionate hourly basis@1.25 times the awarded rate provided the work also suffers in the opinion of Engineer-in-charge due to the afore-said excess downtime. It is preferable that the contractor deploys a replacement vehicle/machine immediately to minimise the down time so that the work does not suffer.
8. The vehicle/machine should remain engaged in the work as per the instructions of Engineer-incharge. If the vehicle/machine remains idle unnecessarily and contrary to the instruction of Engineer-in- charge, causing the work to suffer, penalty for such idle time shall be imposed on the contractor in proportionate hourly basis @ 1.25 times the awarded rate as per the discretion of Engineer-incharge.
