1.0	Bidder should be “Local Supplier” of “Electrically Operated Wind Screen Wiper System” for Driver Cabin for Indian Railway Traction Rolling stock application. Bidder should have supplied minimum 5 Nos (Five) of such item to any establishment of Indian Railways for Traction Rolling Stock application in last five (05) years (To be reckoned from the Bid opening date). Authorised dealer / distributor / agent of such “Local Supplier” can also participate in the tender. Invoice copies date as proof of supply shall be considered as date of supply to meet this criteria. In case bidder is authorised dealer / distributor / agent then bidder can also submit Invoice copies of their Principal as proof of supply.	1. 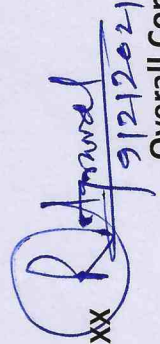

In case any techno-commercially qualified bidder who is authorised dealer/ distributor/ channel partner of a Principal manufacturer, same shall be considered for price bid opening provided their Principal Manufacturer is meeting above criteria for RDSO acceptance.
