- The electrical & mechanical characteristics of bushings shall be in accordance with IS: 2099 IS: 3347 IS: 12676& IEC: 60137.
- Bushings from 52kV upto 420 kV class (including 52 kV and 420 kV class), shall be RIP (Resin Impregnated Paper) Type with composite insulator. It shall be provided with Tap for Capacitance and Tan delta test. All composite resin impregnated bushings (RIP) shall be provided with provision for long term storage to protectfrom moisture and rodents. The oil side shall be provided with tank which can be filled with oil. Tank shall have necessary provision for oil filling, level gauge etc. Suitable covering to be provided on air side to protect from any damage. The arrangement shall be suitable for storage in horizontal / vertical direction in outdoor location.

The oil end dimension of RIP bushing shall be same for all bushings of similar voltage rating.

- Clamps & fittings shall be of hot dip galvanized steel.
